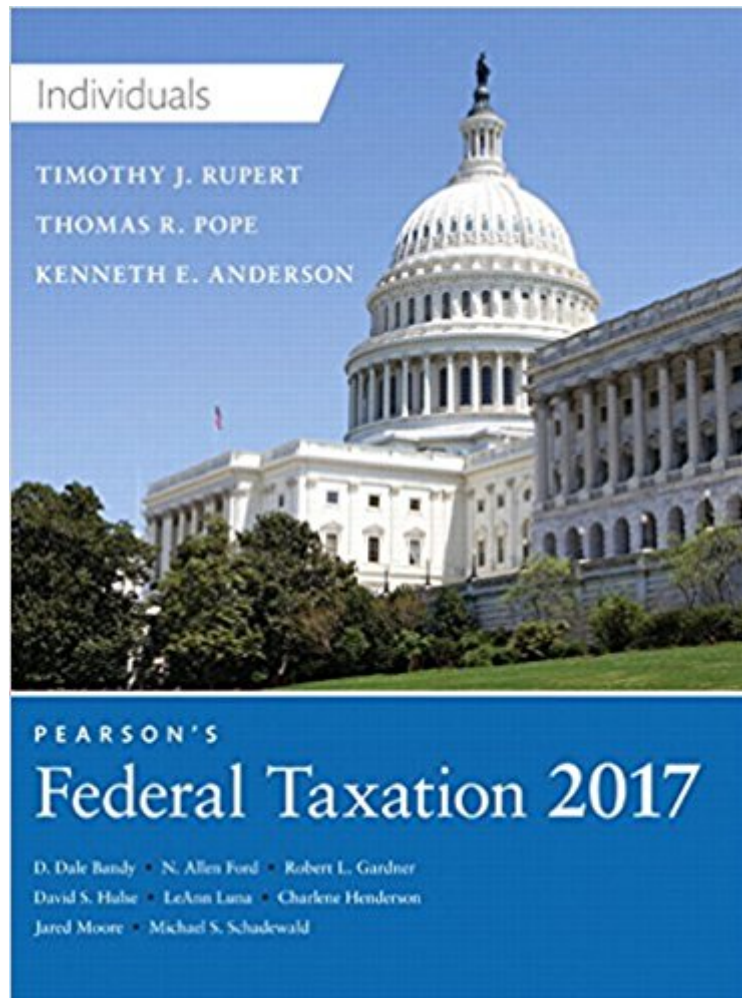

The book is incredibly dense and not helpful. I had to use it for my course so there were no other options. Outside of the few example problems for filling out some forms and some corporations, it is all text. This wouldn't be bad, but the concepts and examples are not always explained well. Many times in the examples they assume you know where all the numbers come from, but forget to explain how or where those numbers came from. Finally, the online resources with the access code were not helpful, because there were not a lot. This may have to do with the instructor, but outside of a power point and some practice test you could do that is all that is offered. Overall if you have a photographic memory and can understand all of this material right away then this book is for you. Otherwise hope your professor uses a different book.
