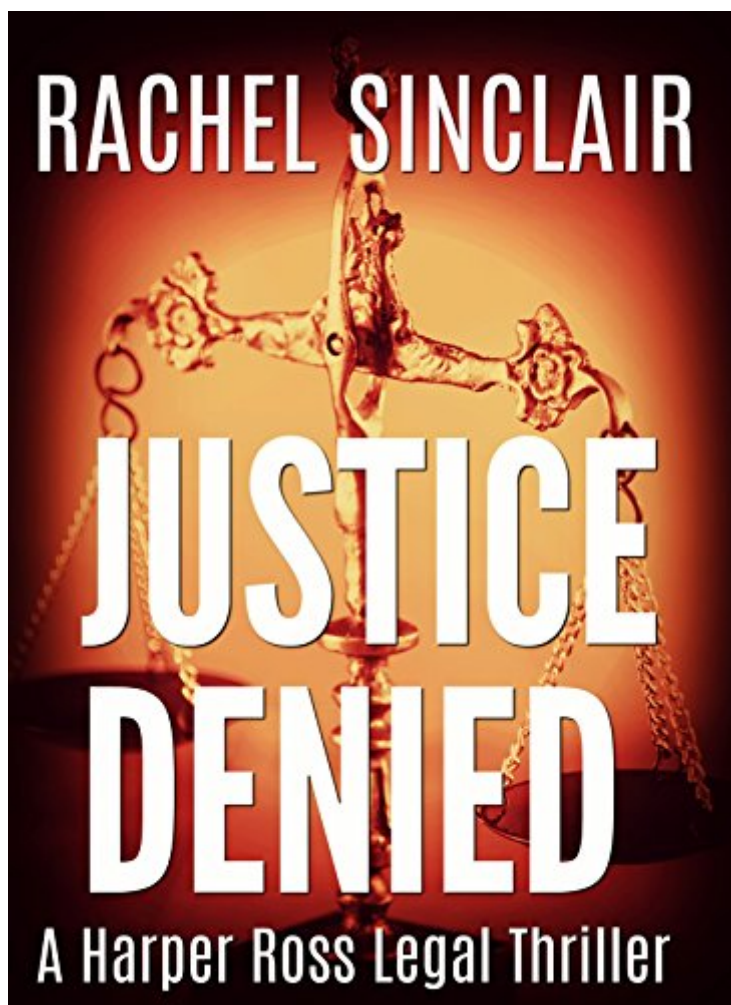

The characters are interesting in this series so far. The story lines keep you coming back for more, too - although this particular book reminded me too much of the "Pelican Brief". One thing about the author's writing style really bothered me, however. What's with all the repeating of sentences and parts of sentences? Very annoying. The proofreader of these books needs to pay more attention to verb tenses, missing words and/or repeated phrases in sentences (lots), and misspellings. Errors on every page!! It makes for difficult reading and is also annoying.
